MEMORANDUM OF ASSOCIATION

In the matter of Act XXI of 1860 being an act for the registration of Literacy, Scientific and Charitable Societies.

- The name of the Society is "BHARGAVA EDUCATIONAL SOCIETY," here in after called 'the Society.'
- The Registered Office of the Society will be situated at MUKAND PUR ROAD, NEAR RAJA GARDEN, VILLAGE GUNACHAUR, NEAR BANGA, DISTRICT SHAHEED BHAGAT SINGH NAGAR.
- 3. The Society will be duly registered with the proper Authorities and area of operation of the society is within District Shaheed Bhagat Singh Nagar.
- 4. The object for which the BHARGAVA EDUCATIONAL SOCIETY is established is to work for the advancement and improvement of educational, intellectual, physical, medical, economic, social, cultural and moral welfare of the public in general and for that purpose:-
 - I. To found, establish, maintain, organize, run, manage, guide and aid the primary and higher schools, colleges and universities, technical institutions, training centers, practical classes, laboratories, research institutions, libraries, reading rooms, coaching classes, lecture halls, exhibition, computer centers, management training centers, examination centers, education information bureau and other educational institutions.
 - II. To found, establish, maintain, organize, run, grant, award supply and aid hostels, boarding houses, scholarships, stipends, studentships, books, food, clothing, residences, prizes, medals and other helps and monetary aids and incentives and loans to meritorious students, research scholars and deserving poor students.
 - III. To found, establish, maintain, organize, run, manage supervise, control and aid dispensaries, hospitals, aushadhalyas, maternity homes, children's hospitals, HIV/AIDS control and prevention programmes, nursing homes, primary health centers, immunization programmes, Hepatitis, sanatoriums, laboratories, operation theaters, after care houses, alms houses, water huts, rescue homes, ashrams and other institutions for widows, destitute orphans, children, blinds, lame and invalids and provide food and shelter and give monetary and other helps. To create disease free society and to run family welfare and planning programmes sponsored by Government agencies.
 - IV. To do relief work and render voluntary services at the time of natural calamities, general disasters and spread of epidemic and contagious diseases and to grant money and materials to other institutions doing and/or engaged, in such relief works.

- To strive and arrange for providing suitable work and means of earning and employment to unemployed persons and for the said purpose teach the willing candidates the method of working and carrying on of all kinds of agricultural. industrial, commercial, business, activities etc.
- To construct, found, establish, maintain, manage and aid Dharmshalas, marriage mandaps, rest houses, parks, historical places, recreating ground, national monuments, buildings and places of ancient art and architecture, bathing ghats and memorials etc. To promote elementary education & human resource development programmes funded by Government agencies
- cu yeu VII. To protect, save and help to alleviate, sufferings and prevent cruelty to animals.
- VIII. To undertake educational propaganda work on public nutrition, health, hygiene and prevention of diseases.
 - IX. To establish harmonious relationship with similar organization and to work in collaboration with them and to accept affiliation of like organizations for fulfillment of the objects of the BHARGAVA EDUCATIONAL SOCIETY.
 - To arrange for or help in preparation, printing, publishing, translating useful books, booklets, pamphlets, periodicals magazines, newspapers, relating to advancement of knowledge and learning and teachings of hygiene, sanitation, social co-operation.
- XI. To issue appeals and applications for money and funds, equipment and materials in the furtherance of the objects of the Society and to accept collect, raise and receive grants and subscriptions, donations securities, loans, deposits and gifts in cash or in kind with or without conditions of the donors / payee for application of such money for a particular object/objects of the Society and agreed to by the governing body of the Society.
- XII. To promote Intensive cultivation, Plantation, Establishment of Tissue Culture Labs, Marketing Support to Agro-Horti-Produces, Livestock feed productions etc.
- XIII. To provide Infrastructural support to existing Teachers Training Institute in the District particularly tribal area for the upliftment of the educated men-power as well as to establish new TTI.
- XIV. To promote integrated rural development activities through agricultural, health promotion, dairy farming, cottage industries development, water shed development and its training to rural population.
- XV. To transform the primitive health care system through setting up a modern health care facilities or by establishing institute for Medical Science/Para-Medical Science/ Cancer Institute / Nursing School and College.

- XVI. To invest and deal with the funds and money of the Society and to vary, alter or to transpose such investments from time to time.
- XVII. To give financial or any other sort of assistance to other Trusts / Society / Organization having similar aims and objectives for the benefit of the community.
- XVIII. To purchase or otherwise acquire or obtain or take on lease or hire temporarily or permanently any movable or immovable property.
- XIX. To sell, mortgage, lease, exchange or otherwise transfer or dispose-off or deal with all or any property, movable or immovable of the Society necessary for the furtherance of the objective of the Society.
- XX. To do or to get done all such other lawful things conducive or incidental or ancillary to the attainment of the above said objects.
 - Provided that: a) The Society shall not support castism or communalism.
 - b) The Society shall extend to the whole District.
- The members of the Society shall be entitled to reimbursement of expenses incurred for carrying out the objects of the Society.
- No addition or amendment or any alteration in this Memorandum of Association shall be made till it is approved by the Simple majority of members of the General Body of the Society at a meeting convened for the purpose.
